REGISTRATION INFORMATION

Pre-registration by mail is requested. Entries may also be registered when they are brought to the Family Arts Building. Each exhibitor must use a separate entry form. Call the Marion County Fair, 317-353-2444 for forms. List each item on a separate line. You select the section number, category letter and number for each of your entries. The fair or a judge will not change the category letters and numbers selected. Items should be clean to qualify for judging and display. **For less than 5 exhibits, enclose \$5.00 for each exhibit. For 5 – 12 exhibits, there will be a flat fee of \$25.00 PER EXHIBITOR with a limit of 12 exhibits. If you wish to enter more than 12 exhibits, enclose an additional \$2.00 for each one as well as the initial \$25.00 fee.** Make check payable to Marion County Fair. There is a \$30.00 fee for returned checks. No cash will be accepted through the mail. NO refunds will be made. Registration at time of entry will be \$6.00 per exhibit.

ENTRY DATE

All exhibits, *except special contests*, **are due Sunday, June 16th between 1 P.M. and 5 P.M.** Entry dates for special contests are listed on pages 8-10. All food is to be in nonreturnable pan. Exhibit tags will be attached to each item at check-in.

RELEASE DATE

Exhibits will be released **on Monday, July 1st from 4 – 7 P.M.** All exhibits should be picked up at this time. Send a friend with your claim tags to pick up exhibits if you are unable to do so. Exhibits not claimed on this date become Marion County Fair property.

OPEN CLASS RULES

1. All exhibitors must be residents of Indiana (**all counties included**) and at least 18 years of age.
2. All exhibits, except foods, must have been produced or completed within the last three (3) years or they will not be judged or displayed.
3. All baked goods become the property of the Marion County Fair; they will be removed from display when spoiled. Pans will not be returned.
4. All hanging exhibits must be wired ready to hang. Clothing hangers must be large enough for the weight of the item. All items must be *clean* to be judged and displayed.
5. **Two (2) single day passes to the fair will be given to each exhibitor who pays the per item fee with a maximum of 2 passes.**
6. **NO cameras will be allowed** except as authorized by the Family Arts Director or Superintendent.
7. Safety precautions will be observed; the Marion County Fair is not responsible for damage or theft.

JUDGING

The judges will not award premiums unless the articles are deemed worthy of merit. Judges will consider workmanship, preparation of the articles for exhibit, suitability for purpose, beauty and originality of design as well as harmony of colors, materials and cleanliness. The Judge's decision is final. Special contest judging will be open to the public. No exhibitor is allowed in the building during Open Class judging. The Director, Superintendent, and designated volunteers will be present only to assist the judges.

RIBBONS AND PREMIUMS

First Place - Blue-\$10 **Second Place** - Red- \$6

Third Place - White- \$4 **Fourth Place** - Pink **Fifth Place** - Yellow

Family Arts Director's Award - \$50 Prize Money

If the Judges deem items worthy, higher ribbon awards may be given: Reserve Champion, Champion, Reserve Grand Champion, Grand Champion or Best of Show

PREMIUMS

Premiums for Open Class must be picked up during the fair at the Treasurer's Office in the Coliseum. Open hours for the Treasurer's Office are listed below. **All checks must be cashed within 30 days.** Premiums are awarded on a class by class basis. Please review class listings for premium assignments. Regardless of the number of entries that place in a class by one exhibitor, the exhibitor will only receive **ONE** premium for that one class.

2019 SPECIAL CONTESTS RULES
(People's Choice and Daily Contests)

1. Participants must be at least 18 years of age and residents of **ANY** Indiana county.
2. **Each exhibitor may enter only one (1) item per contest** and the cost to enter will be \$5.00. Pre-registration is not available for special daily contests.
3. **Exhibitors are not required to pay gate admission for daily contests. Please tell the ticket taker you are a daily contest exhibitor.**
4. Recipes are required for all food entries. The recipes must list ingredients first, followed by instructions. On the reverse side of the recipe, list your name, address, telephone number and the special contest you are entering. All entries are to be made from scratch, no boxed mixes, except where noted. Must serve 6.
5. Entries and recipes become the property of the Marion County Fair. The actual food item should be brought in a **disposable or non-returnable container**. The fair retains the right to use the submitted recipe.
6. Prize structure for people's choice and daily contests is as follows:

1st place - \$40.00
2nd place - \$20.00
3rd place - \$15.00

SECTION II – PHOTOGRAPHY RULES

1. There will be three categories in Photography: **Beginning, Intermediate and Advanced.** All categories include traditional and digital photography.
2. **Beginning** photographers are individuals who have five years or less of photography experience. Most beginners are using their phone or lower end stock camera. The phone photos will be obvious to the judges.
3. **Intermediate** photographers are using stock cameras at a minimum, no phone photos. Some knowledge of editing techniques should be visible. Subject matter should display more than beginning techniques.
4. **Advanced** photographers should have six or more years of experience or have already won in the Beginning/intermediate category. Advanced individuals need to be highly skilled in photo shop and display advanced techniques with equipment that will be obvious to the judges. Experience using multiple light sources will be examined. No phone photos.
5. The photograph itself must be minimum of 8"x10" and maximum of 16"x20" (*including panoramic*). Each photo must be permanently mounted on a solid photographic mount board. Masonite and thin poster board are not acceptable.
6. Overlay mats are acceptable as long as the total thickness of exhibits is no more than 3/16". Overlay mats must be attached on all 4 sides. Exhibitors should be aware that double faced tape or a thin layer of spray glue WILL NOT hold up in high heat and humidity.
7. The un-matted portion of the print shall not be less than 7" x 9" or 63 square inches.
8. All prints must be from negatives, transparencies, or digital and not more than three (3) years old. Prints previously exhibited at the Marion Co. Fair may not be entered again. Family Arts Director reserves the right to reject prints deemed in questionable content. All possible care will be taken to safeguard exhibits; Fair Management will not assume responsibility for loss or damage while in our possession.

SECTION III - FINE ARTS RULES

1. Fine Art is divided into **Beginning/Intermediate Category, Advanced Category and Professional Category.**
2. A **Beginner/Intermediate** is an individual with little or no training and has not established him or herself professionally. They should have had five years or less experience. Copies are allowed in the Non-Professional Category and entries may be work created in a class. Work previously exhibited at the Marion Co. Fair may not be exhibited again.
3. An **Advanced** artist is defined as someone who has previously won an award in the Beginning/Intermediate Category at the Marion County Fair.
4. A **Professional** artist is defined as someone who might be an art instructor, who is doing extended exhibiting or who is selling their art.
5. Work **MUST** be properly framed and wired for hanging. Care will be taken in handling all artwork, but Fair Management will not assume responsibility for loss or damage while in our possession. Broken glass will not be replaced.
6. The Family Arts Director reserves the right to reject artwork deemed objectionable.
