Measurements will be based upon the maximum linear feet the object requires for rental space, i.e., carrying trailers and hitches extending beyond end of the object carried shall be a part of the footage measurement. Fractions of a foot in measurement shall be rounded up to the next full foot, i.e., 22 ft. 2 in = 23 feet

- Full payment is to be made at the time the property is received. An additional fee of \$35 will be charged for any returned checks. Payment may be made in cash OR certified funds.
- A fee of \$50.00 per hour will be charged for removal of property before the end of the storage space. There will be a \$50.00 charge to pre-arrange early removal. The fairgrounds would need 48 hours advance notice of such removal. Once the property is pulled from the storage space, there will be a \$50.00 charge to re-enter the storage area.
- Access to property during storage time will be during normal business hours of the fairgrounds and a \$30.00 fee will be assessed.
- The Marion County Fair does not provide additional security during storage time; however, our normal building security is still in place.
- Keys to vehicles MUST be left on the grounds in case of any natural disaster that would require moving property.
- The Marion County Fair does not take custody or control of the property being stored during storage time, nor does the Marion County Fair provide any clean-up services or other services.

 CLOSED M-F -- Noon to 1:00 pm. Gates will be locked before opening and after closing at specified times. ****NO SUNDAY PICK-UP TIMES WILL BE GIVEN****

- REMOVAL OF PROPERTY FROM ITS STORAGE SPACE WILL BEGIN THE MONDAY PRIOR TO THE ASSIGNED PICK-UP DATES AND PROPERTY WILL REMAIN OUTSIDE UNTIL PICKED UP.
- **LATE PICK-UP FEE: A \$25.00 per day fee will be charged each day property remains on the fairgrounds after the stated pick-up date.**
After April 6th, 2024, the amount will increase to \$35.00 per day. The fee may be paid in cash, certified funds, or by charge card. A charge card transaction will be assessed an additional 5% fee.

The owner shall be responsible for, or carry insurance for, any damages or loss by theft, fire, vandalism, malicious mischief, windstorm, hail, lightning, and other physical damages which may occur on fair premises during the time property is in storage space on said premises.

The Marion County Fair assumes no liability for loss to property or by reason of any claim for personal injury, including death. The owner of property using storage space hereby releases the Marion County Agricultural and 4-H Club Fair, Inc Board, its component members, and their successors from liability of any character and agrees to indemnify said parties from any and all liability by reason of injury to property and/or persons including death which may occur within or upon the premises herein described in any manner connected with use thereof by owner.

In signing this agreement, I expressly declare and represent that all detachable items and accessories have been removed prior to presenting the above described property for storage; and further, I expressly understand that I am releasing the Marion County Agricultural and 4-H Club Fair, Inc. Board, their agents, employees, and successors, and assigns from any liability for loss through theft of all detachable items and accessories present on the vehicle at the time it was presented for storage.

THIS DOCUMENT CONTAINS THE ENTIRE AGREEMENT BETWEEN THE PARTIES HERETO AND THE TERMS OF THIS RELEASE ARE CONTRACTUAL AND NOT MERE RECITAL.
